### **AKC COVID-19 BEST PRACTICES**

The following is a list of best practices that will be enforced while attending this event:

#### General Practices

- Club officials and participants will follow state and local guidelines that apply to the area and site where the event is held.
- Practice social distancing consistent with guidelines in effect at the time.
- Masks must be worn while in the ring by exhibitors, judges, and stewards.
- Hand sanitizer will be available at numerous locations around the site.
   Hand washing station will be available at the portable johns.
- · Avoid shaking hands, hugging, or other physical contact.
- Avoid touching dogs that are not your responsibility.
- Park with sufficient distance between vehicles.
- There will be two ring gates, one for dogs entering and one for exiting.

#### **Exhibitor Practices**

- Plan to be self-sufficient: bring sanitizer, bring a generator for electricity, bring personal use masks. Bring plenty of ice and drinking water.
- Know the armband numbers for your entries before going to the ring.
- Do not congregate at the ring or ring gate.
- While showing your dog, maintain social distances with other exhibitors.
- Grooming beside the exhibitor's vehicle including the use of pop-up tents is recommended. No grooming tent will be provided.
- Fans and hand-held hair dryers must be pointed toward dogs and away from the ring. NO FORCE DRYERS!

#### **Judge Practices**

- All classes should be called in catalog order to provide order and efficiency.
- Judges should practice ring awareness, be conscious of spacing, and avoid crowding of exhibitors.
- Judges are to have the exhibitor display the oral exam.
- Judges should sanitize hands after examining each entry.
- Judges are encouraged to personally pull ribbons for placements.
- Equipment used to measure dogs will be sanitized before and after use.
- Judges have the right to enforce wearing masks in the ring.

#### BEST OF BREED COMPETITION

The following categories of dogs may be entered and shown in Best of Breed competition: Dogs that are Champions of Record. Dogs which according to their owners records have completed the requirements for a championship but whose championships are unconfirmed. The entry and showing of dogs whose championships are unconfirmed is limited to a period of 90 days from the date of the show where a dog completed the requirements for a championship according to the owner's records. If, at the end of the 90 day period, the championship of a dog has not been confirmed by AKC, no further entries of the dog for Best of Breed competition are to be made until its championship has been confirmed by AKC.

#### BRED BY EXHIBITOR CLASS ELIGIBILITY

All dogs entered in the Bred-By Exhibitor Class must be individually registered with the AKC. The person handling the dog must be a breeder of record of the dog and an owner of record of the dog. Family members must be both a breeder and owner of record to exhibit in the class.

NON-REGULAR CLASSES INVOLVING SINGLE DOG ENTRIES CBC & SBBC

NOTE: Winners from these classes are eligible, if undefeated in another class for Best

of Breed Competition.

**Veteran Classes:** For dogs & bitches that are over 7 years old on the day of show. Dogs & bitches that are spayed or neutered ARE eligible to compete in the Non-Regular Veteran Classes. Classes offered for Dogs & Bitches.

7 and under 10 years 10 years and older

**Field Trial Classes:** For dogs & bitches that have earned the title of AKC Field or Amateur Field Champion or that have placed in an AKC licensed or member field trial in a stake where championship points are awarded within the past 2 years until the date of the show.

**Hunting Dog Classes:** For dogs & bitches that have earned the title of Junior Hunter, Senior Hunter or Master Hunter.

#### Junior Showmanship Classes:

Exhibitors should follow their veterinarians' recommendation to assure their dogs are free of internal and external parasites, any communicable diseases, and have appropriate vaccinations.

#### Puppy & Veteran Sweepstakes (CBC only)

Judging will be held before California Brittany Club Regular Classes. Professional handlers are allowed to show in all Sweepstakes classes. All Classes are divided by sex.

#### Puppy Sweepstakes Classes (CBC only):

6 and under 9 months 9 and under 12 months 12 and under 18 months

The Sweepstakes Classes are open to all Brittanys at least 6 months of age and not over 18 months of age on the day of the show. Each entry for the Puppy Sweepstakes MUST BE entered in the CBC Regular Class at this show. Each entry is to indicate "Puppy Sweepstakes" and identify the Class on a regular entry form in the space provided for additional classes. Champions of record are eligible.

#### Veteran Sweepstakes Classes (CBC only):

7 and under 10 years 10 years and older

The Veteran Sweepstakes Classes are open to all Brittany at least 7 years of age on the day of the show. Each entry in Veteran Sweepstakes is not required to be entered in the CBC Regular Classes at this show but we highly encourage you too. Neutered dogs and spayed bitches ARE allowed in Veteran Sweepstakes as well as in the Regular Classes at both CBC and SDBC specialty shows. Each entry is to indicate "Veteran Sweepstakes" and identify the Class on a regular entry form as the class or additional class.

#### JUNIOR SHOWMANSHIP COMPETITION

AKC Junior Handler Numbers are now required for entry in Junior Showmanship Competition. Numbers may be obtained from the American Kennel Club - Phone (919) 233-9767. For additional information, contact American Kennel Club, Junior Showmanship, P.O.Box 900051, Raleigh, NC 27675-9051. Phone (919) 233-9767 or E-mail: juniors@akc.org. Entry forms MUST be filled out with the necessary information, otherwise the entry in Junior Showmanship will not be accepted.

NOVICE CLASS: For Boys and Girls who are at least 9 years and under 18 years old on the day of the show and who, at the time entries close, have not won three First Places, with competition present, in a Novice Class at a licensed or member show.

OPEN CLASS: For Boys and Girls who are at least 9 years and under 18 years old on the day of the show and who, at the time entries close, have won three First Places, with competition present, in a Novice Class at a licensed or member show.

MASTER CLASS: This class will be for Boys and Girls who are at least 9 years old and under 18 years on the day of the show, and who have 10 Best Junior wins with competition. The calendar for this class will be consistent with the eligibility dates for the AKC National Championship. All Juniors meeting the criteria for this class are required to enter the Master Class and may change their entry the day of the show if entries have already closed. Once the eligibility time frame for that year has passed, all participants return to the Open Class to compete for the following year.

- 2. The following categories of dogs may be entered and shown in Best of Breed competition: Dogs that are Champions of Record and dogs which, according to their owners' records, have completed the requirements for a championship, but whose championships are unconfirmed. The showing of unconfirmed Champions in Best of Breed competition is limited to a period of 90 days from the date of the show where the dog completed the requirements for a championship.
- 3. (Event Class) Consult the classification in this premium list. If the event class in which you are entering your dog is divided, then, in addition to designating the class, specify the particular division of the class in which you are entering your dog, i.e., age division, color division, weight division.
- 4. A dog must be entered in the name of the person who actually owned it at the time entries for an event closed. If a registered dog has been acquired by a new owner it must be entered in the name of its new owner in any event for which entries closed after the date of acquirement, regardless of whether the new owner has received the registration certificate indicating that the dog is recorded in his name. State on entry form whether transfer application has been mailed to the AKC. (For complete rules, refer to Chapter 11, Section 3.)

#### **NOTICE TO EXHIBITORS**

- 1. Entries must reach the Show Secretary, Lea Plaut, 16750 Paradise Mtn Road, Valley Center, CA 92082 6:00 PM, Wednesday, September-9, 2020 Fees should accompany entries. The Club and the Show Secretary assume no responsibility for wrong or incomplete information given on the entry blank by the owner or agent of the owner. The Club and the Show Secretary assume no responsibility for the owner or owner's agent entering a dog in a class in which the dog is not eligible to compete, or for entering the same dog twice.
- Returned checks do not constitute a valid entry fee. The CLUB will add a collection fee to the amount of each returned check. Subsequent returned checks for the same exhibitors may result in their being put on a CASH ONLY basis. The returned check MUST BE MADE GOOD by cash or money order BEFORE the dog will be allowed in the ring.
- 3. Exhibitors' confirmations and judging programs will be mailed to the address given on the entry blank. If not received within a reasonable time prior to the show, notify the Show Secretary. Confirmations returned by the Post Office marked "Undeliverable" will be held at the Show Secretary's office. PLEASE BRING YOUR CONFIRMATIONS TO THE SHOW.
- 4. During the hours of judging owners are to be on call, and have their dogs ready to bring into the judging ring promptly in order that judging will not be delayed. Dogs need only be present for their judging. Dogs not needed for further judging may be excused. It is the responsibility of the exhibitor to have his dog ready to be shown and at the entrance of the judging ring when the steward calls for the class. Owner of dogs or the handlers of the dogs alone are responsible for the presence of their dogs in the judging rings. This means it is not the responsibility of the ring steward, nor of any agent of the show-giving club to locate any dog, it's owner or handler, when the dog's presence is needed in a judging ring. It should be understood by every exhibitor and handler that waiting for dogs to be brought into the ring is a courtesy extended to the owner or handler of the dog. There is no rule of these clubs nor the American Kennel Club that requires a judge to wait for an owner or handler to bring his dog into the ring. Show hours 6 AM to 8 PM.
- 5. Trophies and prizes will be awarded in the judging ring by completion of the breed and the show secretaries office advised at once, in the event of any discrepancy. All trophies must be claimed the day of the show. None will be mailed.
- Exhibitors are admonished to make themselves familiar with the agreement of the American Kennel Club, referred to on the reverse side of the entry blanks that accompany the premium list. Rule books may be obtained from the A.K.C., 5580 Centerview Dr., Suite 200, Raleigh, N.C. 27606.
- 7. The Club, the Show Secretary or the members or employees will not be responsible for the loss of or damage to any dog exhibited, whether the result of accident or other causes and in addition assumes no responsibility for any loss, damage or injury sustained by an exhibitor/owner or handler. It is distinctly understood that every dog at this show is in the care and custody and control of his owner or handler/agent during the entire time the dog is on the show premises.
- 8. No grooming tables, pens or exhibitors setups will be allowed in the aisles and all grooming must be done at least 20 ft. away from the judging ring in areas specified by the club.
- 9. Entry fees shall NOT be refunded in the event that a dog is absent, disqualified, sick, lame, excused by veterinarian or judge, barred from competition by action of the Event Committee, or because the dog is ineligible to compete due to being entered incorrectly. There is no refund of entry fees for duplicate entry.
- 10. Only dogs that are eligible to compete to be allowed on the grounds.
- 11. The Southern California Ibizan Hound Club, may decline any entries for cause and may refuse to receive or may remove any dog on account of disease, viciousness or other causes, and no one shall have any claim or recourse against the Club or any official thereof.
- 12. If, because of riots, civil disturbances or other acts beyond the control of the management, it is impossible to open or complete the show, no refund of entry will be made.
- 13. Do not leave any dogs in closed vehicles.
- 14. A recording fee of 50 cents per dog and an event service fee of \$3.00 per entry will be required for each dog entered at any Licensed or Member Club Show. These fees are to be collected by the Show-giving Club and paid to the American Kennel Club. (American Kennel Club Rule, Chapter 11, Section 2.)
- 15. Dogs which according to their owners records have completed the requirements for a championship after the closing of entries for the show but whose championships are unconfirmed, may be transferred from one of the regular classes to the Best of Breed Competition, provided this transfer is made by the Show Secretary at least one half hour prior to the start of the earliest Confirmation judging at the show.
- 16. All persons attending this event hereby waive any claim for damages against the Club, or its, members, in the event a motor vehicle has to be entered to rescue a dog from overheating or improperly vented conditions.
- 17. All vehicles parked in VIP Parking Area without VIP Pass will be ticketed and fined.


