PARKING

DAY OF SHOW PARKING (THURSDAY TO MONDAY)

Parking is payable to Fairplex upon arrival. Do not mail ahead of time. Gates open 6:00 AM. Parking is \$10.00, motor homes will cost more.

RESERVED OVERNIGHT PARKING HOURS

Wednesday 4 pm-10 pm
Thursday 6 am – 7 am & 5 pm – 10 pm
Friday & Saturday & Sunday 6 am – 7 am & After Best in Show – 10 pm
Monday 6 am – 7 am

POWER

The power will be turned on at 5 pm on Wednesday and turned off on Monday at 5 pm. Any damage caused to any power that is supplied by Event Power Solutions or the Pomona Fairgrounds equipment, is the sole responsibility of the person whose vehicle caused that damage while plugged into that power. These damages must be paid for at the time of the damage.

All parking will be on asphalt. Bring appropriate ground cover. Plastic must be under saw dust and plastic wrapped up sides of x-pens to prevent saw dust from blowing into other set-ups, and MUST be cleaned up at departure.

Each parking space is for one vehicle only. (Trailer and tow vehicle are considered as one vehicle.) You may purchase a Tag Vehicle permit for \$5.00 per night. All vehicles MUST be parked inside the lines of your assigned space.

If you wish to park together you MUST send your reservation forms in one envelope. No separate requests.

Your area must be left clean when leaving Fairplex. NO washing of mats or dog equipment.

Any vehicles parked illegally (aisles, fire lanes, no parking areas) will be towed at the owner's expense.

Any arguing or abusive language to members of the parking crew and you will forfeit all parking privileges for the rest of the circuit.

There will be no refunds, and the matter will be referred to the Bench Show Committee.

There is a waste-dump station located by the bathroom in the picnic hill area. No discharging of grey water or sewage in undesignated areas.

No electrical cords can run across any roadways or fire lanes.

Handicap parking may not be close to the rings but will have easy ring accessibility. You need to send a copy of your handicapped license with your name on it. (No copies of placards will be accepted.)

If your check is returned and not cleared up within a three-month period, you may be denied future entries and parking. \$25.00 returned check fee

Reservations close when entries close. No refunds after the closing date. Do not send mail that needs a signature. **Make check payable to SFKC.** E-mail confirmations will be sent if a legible e-mail is provided.

UNRESERVED & OVERNIGHT PARKING: Fees for Under 40 feet are \$50.00 per night. Over 40 feet will be \$55.00 per night. All of the rules above will apply. Unreserved power requires a separate check for \$60 per night with a three night minimum.

## NOHS

### Judging Procedures for the AKC National Owner-Handled Series

#### Determining Exhibitor Eligibility

The first step in judging the AKC National Owner-Handled Series is determining exhibitor eligibility. Follow these tips to properly make the eligibility determination:

Exhibitors must declare their dog AKC National Owner-Handled Series eligible at the time of entry using the check box on the entry form. The handler must be an owner of record according to the AKC's records as of the date of the show. Dogs declared eligible will be identified by an asterisk or other representative mark in the steward's book and in the show catalog. Professional handlers, household members and current assistants to professional handlers may not exhibit. A current assistant is defined as anyone employed by a professional handler on a full-time basis, or, assisting a professional handler at the show or any show during the cluster/weekend.

Dogs must be handled by an owner-handler eligible for the AKC National Owner-Handled Series throughout the breed level competition for the regular show. This includes the class competition and subsequent competition in the breed ring. Additionally, dogs must be handled by an eligible owner-handler for all AKC National Owner-Handled Series competition. The Owner-Handled Best of Breed will be selected from the eligible dogs that competed in the Best of Breed/Variety competition for the regular show. This includes Winners Dog, Winners Bitch, and the undefeated winners of the non-regular classes. *This excludes all dogs defeated during class and winners competition for the regular show.*

#### Determining Best of Breed/Variety

Breed judging for the AKC National Owner-Handled Series is conducted following Best of Breed judging in each breed ring. All dogs in the BOB competition (including WD & WB) will stay in the ring after the judge makes their placements in BOB competition. The ring steward will ask all professional handlers, household members of and current assistants to a professional handler, and any exhibitor that did not indicate on their entry that they were eligible for the AKC National Owner-Handled Series to leave the ring and then the judge will then select the Owner-Handled Best of Breed. A dog being "cut" or otherwise "defeated" in the Best of Breed ring remains eligible to compete in the AKC National Owner-Handled Series. The Owner-Handled Best of Breed will be selected from the eligible exhibits based on the program guidelines and procedures.

Judging of the breed/variety for the regular show may determine the dog that is awarded Owner-Handled Best of Breed. Please follow these guidelines:

If the Best of Breed/Variety winner of the regular show is eligible for the AKC National Owner-Handled Series competition, it will also be awarded Owner-Handled Best of Breed. In this case the dog will be eligible to compete in group competition for the regular show and group competition for the AKC National Owner-Handled Series.

If the regular show Best of Breed/Variety winner is not eligible for AKC National Owner-Handled Series competition and the regular show Best of Opposite Sex to Best of Breed/Variety is eligible, the regular show Best of Opposite Sex to Best of Breed/Variety will compete against the eligible exhibits of the other sex to determine Owner-Handled Best of Breed.

If neither the Best of Breed nor the Best of Opposite Sex to Best of Breed/Variety from the regular show is eligible for the AKC National Owner-Handled Series competition and both the Select Dog and Select Bitch are eligible, the judge is to choose Owner-Handled Best of Breed from the Selects and any eligible Winners Dog or Winners Bitch.

If one of the Selects from the regular show is eligible for AKC National Owner-Handled Series competition, excuse all eligible champions and non-regular class winners of the same sex and then choose Owner-Handled Best of Breed from the remaining eligible dogs of the opposite sex including the eligible Winners.

If the regular show Best of Breed, Best of Opposite Sex to Best of Breed, Select Dog & Select Bitch are not eligible, the judge may choose any eligible dog who competed in Best of Breed including Winners Dog or Winners Bitch as the Owner-Handled Best of Breed. (Effective 10/9/14)

## PUPPY SWEEPSTAKES

### Puppy Sweepstakes Rules

1. Dogs shown in Sweepstakes must ALSO be entered in one of the Regular Classes at the regular fee and on the regular entry form.
2. There shall be a separate stakes for each coat variety
3. In the following classes, Longhaired, Smooth, Wirehaired Varieties will be judged separately and 30% of each Variety stake will be reserved for expense. The balance will be divided in the proportion of 40% First Place, 30% Second Place, 20% Third Place, 10% Fourth Place. The Best in Sweepstakes will receive any unclaimed monies so that the Club will not retain over 30%.

## JUNIOR SHOWMANSHIP COMPETITION

**Novice Junior Class:** For Boys and Girls who are at least 9 years old and under 12 years old on the day of the show and who, at the time entries close, have not won three First Place awards with competition present in a Novice Class at a licensed or member show.

**Novice Intermediate Class:** For Boys and Girls who are at least 12 years old and under 15 years old on the day of the show and who, at the time entries close, have not won three First Place awards with competition present in a Novice Class at a licensed or member show.

**Novice Senior Class:** For Boys and Girls who are at least 15 years old and under 18 years old on the day of the show and who, at the time entries close, have not won three First Place awards with competition present in a Novice Class at a licensed or member show.

**Open Junior Class:** For Boys and Girls who are at least 9 years old and under 12 years old on the day of the show and who, at the time entries close, have won three First Place awards with competition present in a Novice Class at a licensed or member show.

**Open Intermediate Class:** For Boys and Girls who are at least 12 years old and under 15 years old on the day of the show and who, at the time entries close, have won three First Place awards with competition present in a Novice Class at a licensed or member show.

**Open Senior Class:** For Boys and Girls who are at least 15 years old and under 18 years old on the day of the show and who, at the time entries close, have won three First Place awards with competition present in a Novice Class at a licensed or member show.

Each dog handled in a Junior Showmanship Class must be entered in one of the Breed Obedience Classes at the show, or must be entered for Junior Showmanship only. However, a dog may be substituted. Such substitution must be accompanied by an official AKC entry form. All such substitutions must be made one half-hour prior to the judging of any Junior Showmanship Classes at the show. Each dog must be owned or co-owned by the Junior Handler or by the Junior Handler's father, mother, brother, sister, uncle, aunt, grandfather or grandmother, including step and half relations or by a member of the Junior Handler's household. Every dog entered for Junior Showmanship must be eligible to compete in Dog Shows or in Obedience Trials. BITCHES IN SEASON ARE NOT ELIGIBLE. A dog that has been excused or disqualified by a Breed Judge or by a Bench Show Committee may still be handled in Junior Showmanship if eligible to compete in Obedience Trials. A dog that has been rejected, dismissed, or excused by the Veterinarian for the protection of the other dogs at the show or for the protection of the dog excused may not be handled in Junior Showmanship. Junior Handlers who win a third Novice Class with competition present after the closing of entries for a show may transfer their entry from the Novice Class to the Open Class provided that this transfer is made by the Secretary at least one half-hour prior to the scheduled start of any regular conformation judging or one half-hour prior to the scheduled start of Junior Showmanship judging at the show, whichever is earlier. Winning of first place in an Open Class at this show may qualify or count toward qualification for entry in certain future limited Junior Showmanship Classes. For information on eligibility requirements for limited Junior Showmanship Classes which have been approved to date by AKC. PLEASE NOTE: ALL JUNIOR HANDLERS ARE REQUIRED TO HAVE AN AKC NUMBER prior to the day of the event. Numbers may be obtained from the American Kennel Club, call (919) 816-3776. Junior Handlers must put their nine-digit number on the entry blank. Be sure to include all information required on both the front and back of the official AKC entry form. NOTICE: EFFECTIVE JANUARY 1, 2005, competition is required for awarding of Best in Junior Showmanship. That is, there must be entries in at least two classes.

## Challenge Trophies

Challenge trophies are offered through the Sierra Dachshund Breeders Club of Los Angeles County, for competition at its shows only. For permanent possession must be won three times by one owner, (it no longer needs to be identical owners) not necessarily with the same dog nor at consecutive shows. ALL CHALLENGE TROPHIES SHALL REMAIN IN THE POSSESSION OF THE SIERRA DACHSHUND BREEDERS CLUB OF LOS ANGELES COUNTY UNTIL RETIRED.
