SECTION 7. (effective as of 1/1/2009) The Amateur-Owner-Handler class shall be for dogs that are at least six months of age that are not champions. Dogs must be handled in the class by the registered owner of the dog. This class is restricted to exhibitors who have not, at any point in time, been a professional dog handler, AKC approved conformation judge, or employed as an assistant to a professional handler. Additionally, members of the immediate family or household of a current professional handler are ineligible for this class (as defined in Chapter 11, Section 13). Professional handlers are defined as any person who belongs or has belonged to a professional handlers' organization, distributed rate cards, or otherwise advertised or represented themselves as handling dogs for pay.

**NON-REGULAR CLASSES, INVOLVING SINGLE DOG ENTRIES**

**Veteran Dogs (over 6 Years of Age) Veteran Bitches (Over 6 Years of Age)**

\*Chapter 11, Section 8 of the "Rules Applying to Dog Shows" provides that a Neutered Male or Spayed Bitch may be entered as a Veteran. Winners of the above class are eligible to compete in Best of Breed Competition.

**BEST OF BREED**

**(No defeated dogs will be allowed to compete, Chapter 3, Section 13 of the Rules Applying to Dog Shows)**

The following categories of dogs may be entered and shown in Best of Breed competition: Dogs that are Champions of Record. Dogs which according to their owners records have completed the requirements for a championship but whose championships are unconfirmed. The entry and showing of dogs whose championships are unconfirmed is limited to a period of 90 days from the date of the show where a dog completed the requirements for a championship according to the owner's records. If, at the end of the 90 day period, the championship of a dog has not been confirmed by AKC, no further entries of the dog for Best of Breed competition are to be made until its championship has been confirmed by AKC.

**GRAND CHAMPION JUDGING PROCEDURE**

On May 12, 2011 the Grand Championship competition will start concurrent with the implementation of the 2010-2011 Schedule of Points. Competition for this new title will be judged concurrently with Best of Breed/Variety competition at both all-breed and specialty shows.

All Champions of record that are eligible to be entered in Best of Breed/Variety competition, are automatically entered in competition for points toward the "Grand Champion" title when they are entered in the Best of Breed/Variety class at a dog show. Dogs and bitches that have earned their Championship and moved up to the Best of Breed/Variety as well as winners from the "Non Regular classes would be eligible to compete on the day. Neither Winners Dog nor Winners Bitch is eligible to compete for "Grand Champion" points. There are no additional entry fees or cost to exhibitors for the participation in this competition at AKC events.

The Grand Champion competition is an extension of the traditional system to earn an AKC Championship on a dog. It is simple, similar in format to that used to finish a dog, and, because it focuses exclusively on competition at the breed level, it will add minimal time to the current judging process. The Best of Breed/Variety judge will award Best of Breed/Variety, Best of Winners, Best of Opposite Sex, \*Select Dog and \*Select Bitch. This is simply adding two placements and two additional ribbons for the Select Dog and Bitch to be awarded. Judges may withhold any Grand Champion awards at their discretion.

The Best of Breed/Variety judge will be required to certify that awarding of Grand Championship points are to eligible and deserving dogs.

\*Non Regular class winners that are not Champions of Record are not eligible to be awarded Grand Championship points and any points awarded would have these points disallowed administratively by the AKC. The Select Awards have no relationship or correlation to Awards of Merit and judges should continue to review the premium list for criteria in making these awards.

**NON-REGULAR CLASSES INVOLVING MULTIPLE DOG ENTRIES**

**STUD DOG CLASS:** For Stud Dogs and two of their Get. Stud Dogs must be entered in Stud Dog Class and must be shown in the ring with their Get. Get only to be judged based upon the merits of the Get. Get must be entered in a regular class, Best of Breed or other Non-Regular class.

**BROOD BITCH CLASS:** For Brood Bitches and two of their Produce. Brood Bitches must be entered in Brood Bitch Class and must be shown in the ring with their Produce. Produce only to be judged based upon the merits of the Produce. Produce must be entered in a regular class, Best of Breed or other Non-Regular Class. As the judge's decision in the Stud Dog/Brood Bitches and Brace Classes will be based on the merits of more than one dog or bitch, no one of the dogs or bitches making up the entry judged first in the class will be eligible to compete for Best of Breed by virtue of having won the class.

**BRACE CLASS:** For two Pomeranians with identical ownership. If a dog which is part of a brace is not entered in any of the regular classes, it must be entered for "Brace Only". A dog entered in a regular class and entered as part of a brace, must be marked accordingly in the space provided for Additional Classes. Entry forms must be submitted together.

**SPECIAL AWARDS**

**AWARDS OF MERIT:** At the conclusion of Best of Breed, after picking Best of Breed and Best of Opposite Sex to Best of Breed, the Specialty Judge at his/her discretion may award Rosettes for Judges Awards of Merit to a maximum of 10% of the Best of Breed entry. The judge is not obligated to award any Awards of Merit if he/she feels there are not any dogs or bitches in competition worthy of this award. All dogs competing in the Best of Breed competition are eligible for this award with exception of the Best of Breed winner.

**BEST PUPPY FROM THE REGULAR CLASSES:** Best Puppy will be selected from the first place winners of the 6-9 mos. and 9-12 mos. Classes, Dogs & Bitches.

**BEST BRED-BY-EXHIBITOR (BBE), BEST BRED-BY-EXHIBITOR OF OPPOSITE SEX:** Best Bred by Exhibitor and Best Bred by Exhibitor of Opposite Sex will be selected from the First Place Winners from the BBE Dog and Bitch Classes.

**BEST VETERAN:** will be selected from the First Place Winners of the Veteran Dog and Veteran Bitch Classes.

**PARADE OF TITLEHOLDERS:** All Pomeranian AKC Champions of Record are eligible to enter this Parade of Titleholders. An entry fee of \$15.00 will be charged. Each dog will receive a rosette offered by COAPC. This is a non-competitive class.

## Puppy & Veteran Sweepstakes

### PUPPY SWEEPSTAKES RULES

The Puppy Sweepstakes is open to all Pomeranians who are 6 months of age and under 18 months of age on the day of show. All Dogs entered in the Sweepstakes must be entered in the regular class. Champions of Record are NOT eligible for Sweepstakes Classes. Class prizes will be paid in the ring before the Sweepstakes judging is complete. The Club and Show Secretary disclaim any liability for prizes after the judging is complete. Classes Offered in Puppy Sweepstakes:

#### Classes for Dogs & Bitches

6 months & under 9 months      9 months & under 12 months      12 months & under 18 months

Best In Sweepstakes And Best Opposite In Sweepstakes Will Be Chosen From Winners Of The Above Classes.

Prize Money: The City of Angels Pomeranian Club will retain 35%.

Best in Sweepstakes ~ 6%      Best Opposite in Sweepstakes ~ 4%

The remaining 55% will be divided as follows, classes of 4 or more:

First Prize 40%      Second Prize 30%      Third Prize 20%      Fourth Prize 10%

## SCHEDULE OF POINTS EFFECTIVE MAY 11, 2012

For complete Conformation Championship requirements see Chapter 16 of the *Rules Applying to Dog Shows*

The Points toward a Championship shall be awarded to the Winners Dog and Bitch of each breed or variety based on the actual number of dogs or bitches compet-  
ing in that breed or variety. If the dog designated Winners Dog or Winners Bitch is also awarded Best of Breed or Variety, the dogs of both sexes that have been entered for  
Best of Breed or Variety competition and that have been defeated in competition, shall be counted in addition to the dogs that competed in the regular classes for its sex in  
calculating championship points. If the dog designated Winners Dog or Winner Bitch is also awarded Best of Opposite Sex to Best of Breed or Variety, the dogs of its own  
sex that have been entered for Best of Breed or Variety competition that have been defeated in competition for Best of Opposite Sex, shall be counted in addition to the dogs  
that competed in the regular classes for its sex in calculating championship points. After points have been computed for Winners Dog and Winners Bitch subject to the  
above two stipulations, the dog awarded the Best of Winners shall be credited with the number of points calculated for Winners Dog or Winners Bitch, whichever is greater.  
In counting the number of eligible dogs in competition, a dog that is disqualified, or that is dismissed, excused or ordered from the ring by the judge, or from which all awards  
are withheld shall not be included. Any dog which shall have won fifteen points shall become a Champion of Record, if six or more of said points shall have been won at two  
shows with a rating of three or more championship points each and under two different judges, and some one or more of the balance of said points shall have been won  
under some other judge or judges than the two judges referred to above.
