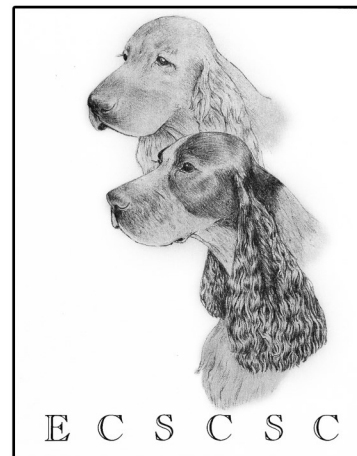

JUNIOR SHOWMANSHIP

Novice Junior Class: For Boys and Girls who are at least 9 years old and under 12 years old on the day of the show and who, at the time entries close, have not won three First Place awards with competition present in a Novice Class at a licensed or member show.
Novice Intermediate Class: For Boys and Girls who are at least 12 years old and under 15 years old on the day of the show and who, at the time entries close, have not won three First Place awards with competition present in a Novice Class at a licensed or member show.
Novice Senior Class: For Boys and Girls who are at least 15 years old and under 18 years old on the day of the show and who, at the time entries close, have not won three First Place awards with competition present in a Novice Class at a licensed or member show.
Open Junior Class: For Boys and Girls who are at least 9 years old and under 12 years old on the day of the show and who, at the time entries close, have won three First Place awards with competition present in a Novice Class at a licensed or member show.
Open Intermediate Class: For Boys and Girls who are at least 12 years old and under 15 years old on the day of the show and who, at the time entries close, have won three First Place awards with competition present in a Novice Class at a licensed or member show.
Open Senior Class: For Boys and Girls who are at least 15 years old and under 18 years old on the day of the show and who, at the time entries close, have won three First Place awards with competition present in a Novice Class at a licensed or member show.
Master Class: This class will be for boys and girls who are at least 9 years old and under 18 years on the day of the show, and who have won 10 first place wins in an Open class with competition to be eligible to enter the Limited Class Competition. The calendar for this class will be November 1 – October 31 of the following year. All Juniors meeting the criteria for this class are required to enter the Master Class and may change their entry the day of the show if entries have already closed. Once the eligibility time frame for that year has passed all participants return to the Open Class to complete for the following year.
Each dog handled in a Junior Showmanship Class must be entered in one of the Breed or Obedience Classes at the show, or must be entered for Junior Showmanship only. However, a dog may be substituted. Such substitution must be accompanied by an official AKC entry form. All such substitutions must be made one half-hour prior to the judging of any Junior Showmanship Classes at the show. Each dog must be owned or co-owned by the Junior Handler or by the Junior Handler's father, mother, brother, sister, uncle, aunt, grandfather or grandmother, including step and half relations or by a member of the Junior Handler's household. Every dog entered for Junior Showmanship must be eligible to compete in Dog Shows or in Obedience Trials. BITCHES IN SEASON ARE NOT ELIGIBLE. A dog that has been excused or disqualified by a Breed Judge or by a Bench Show Committee may still be handled in Junior Showmanship if eligible to compete in Obedience Trials. A dog that has been rejected, dismissed, or excused by the Veterinarian for the protection of the other dogs at the show or for the protection of the dog excused may not be handled in Junior Showmanship. Junior Handlers who win a third Novice Class with competition present after the closing of entries for a show may transfer their entry from the Novice Class to the Open Class provided that this transfer is made by the Superintendent at least one half-hour prior to the scheduled start of any regular conformation judging or one halfhour prior to the scheduled start of Junior Showmanship judging at the show, whichever is earlier. Winning of first place in an Open Class at this show may qualify or count toward qualification for entry in certain future limited Junior Showmanship Classes. For information on eligibility requirements for limited Junior Showmanship Classes which have been approved to date by AKC go online at akc.org Junior Handler's must include their AKC Junior Handler identification number on the entry blank. You may obtain your number by calling the AKC Event Records Department (919) 233-9767. Notice: Be sure all information for Junior Showmanship Classes is entered on the front and back of the entry form

IN LOVING MEMORY OF SUSIE LAFEVER

Susie LaFever was born in Australia on November 15, 1937. She and her husband, Minard, were early members of the English Cocker Spaniel Club of Southern California. In the early days of the ECSCSC, Susie wrote a column for the newsletter titled "Luella Paws" full of tidbits, brags and gossip for the fancy. Susie raised and campaigned several champion English Cocker Spaniels, under the kennel name "Mysthill". Her "Woody", Ch. Mysthill's Woodwynde, was a top winning EC for a several years, expertly shown by the late Tom Tobin, and by her friend and fellow EC owner, Stefani Batastini. Woody was from a litter Susie co-bred with Debbie Campbell which produced two other specialty winning English Cockers including Ch. Sandcastle Skipjack ECM. Ch. Stirling's Sentimental Blue, Coltrane, another Woody son, is owned by ECSCSC members Curt Neely and Nina Skorus-Neely. Susie and her dear friend Jan Fleming co-owned the Woody son, Ch. Barrister Space Ranger, "Buzz", bred by Sally Rosenthal. Buzz was BOS in Sweeps and Reserve Winners Dog at the ECSCA National as a youngster, handled by Jan Fleming under Bonnie Threlfall and Ginny Lyne respectively. Later, he went on to take BISS at our ECSCA National under Eileen Weston, handled by Julie Kay and garnered other specialty wins as well. Susie was an intelligent, kind and compassionate person who was knowledgeable about so many things. She raised sheep, goats and chickens, and was a marvelous spinner of wool. In addition, her gardening prowess was immense, and she worked many years in her own large organic garden, as well as in the plant nursery business, sharing that knowledge with so many. Susie loved her family, life and enjoyed time together with her English Cockers. She was always a strong supporter of our Club and was active with English Cocker Rescue. Susie was always willing to foster the older ECs that were so hard to place and could be counted on to take them in. On May 7th, 2013 Susie was suddenly taken from us and sadly never realized her dream of moving back to be closer to her children and grandchildren. She lived a rich full life and made the world a better place for her being here. The English Cocker Spaniel Club of Southern California dedicates this Specialty Show to the memory of our dear member, Susie LaFever.
