BEST OF BREED

(No defeated dogs will be allowed to compete)

The following categories of dogs may be entered and shown in Best of Breed competition: Dogs that are Champions of Record. Dogs which according to their owners records have completed the requirements for a championship but whose championships are unconfirmed. The entry and showing of dogs whose championships are unconfirmed is limited to a period of 90 days from the date of the show where a dog completed the requirements for a championship according to the owner's records. If, at the end of the 90 day period, the championship of a dog has not been confirmed by AKC, no further entries of the dog for Best of Breed competition are to be made until its championship has been confirmed by AKC.

NON-REGULAR CLASSES INVOLVING MULTIPLE DOG ENTRIES

Stud Dog Class: For dogs that have sired two dogs or bitches entered in this show. The award will be based on the merits of the get. The owner of the stud dog need not be the owner of the get. As the judge's decision in this class will be based on the merits of more than one dog or bitch, no one of the dogs or bitches making up the entry judged first in the class, will be eligible to compete for Best of Breed by virtue of having won this class. The Stud Dog must appear in the ring with his get and be entered in the Stud Dog Class.

Brood Bitch Class - For bitches that have whelped two dogs or bitches entered in this show. The award will be based on the merits of the produce. The owner of the brood bitch need not be the owner of the produce. As the judge's decision in this class will be based on the merit of more than one dog or bitch, no one of the dogs or bitches making up the entry judged first in the class will be eligible to compete for Best of Breed by virtue of having won this class. The Brood Bitch must appear in the ring with her produce and be entered in the Brood Bitch Class.

AWARD OF MERIT

After awarding Best of Breed, Best of Winners and Best of Opposite Sex, the judge may award up to a maximum of six (6) Awards of Merit to exhibits in the Breed ring that are, in the judge's opinion, outstanding specimens. The total number of Awards of Merit the judge is allowed to award is determined by the total number of dogs and bitches competing in the Best of Breed competition, as follows: 1 for 7 – 10; up to 2 for 11 – 16; up to 3 for 17 – 23; up to 4 for 24 – 30; up to 5 for 31 – 36; up to 6 for 37 and over. ** The Select Dog and Select Bitch will automatically receive the NCA Award of Merit, "if" there is only one AOM to be given, it will be at the judges choice.

NOTICE TO ALL EXHIBITORS - Rules Applying to Dog Shows, Effective January 1, 2010

CHAPTER 11, SECTION 1. No dog shall be exhibited in a licensed or member dog show, except for dogs entered in the Miscellaneous Class unless it is either individually registered in the AKC Stud Book, or individually registered with a foreign registry organization whose pedigrees are acceptable for AKC registration.
