*Chapter 11, Section 8 of the "Rules Applying to Dog Shows" provides that a Neutered Male or Spayed Bitch may be entered as a Veteran. Winners of the above class are eligible to compete in Best of Breed Competition.

BEST OF BREED

(No defeated dogs will be allowed to compete)

The following categories of dogs may be entered and shown in Best of Breed competition: Dogs that are Champions of Record. Dogs which according to their owners records have completed the requirements for a championship but whose championships are unconfirmed. The entry and showing of dogs whose championships are unconfirmed is limited to a period of 90 days from the date of the show where a dog completed the requirements for a championship according to the owner's records. If, at the end of the 90 day period, the championship of a dog has not been confirmed by AKC, no further entries of the dog for Best of Breed competition are to be made until its championship has been confirmed by AKC.

NON-REGULAR CLASSES INVOLVING MULTIPLE DOG ENTRIES

The Stud Dog or Brood Bitch classes will be for Stud Dogs or Brood Bitches and two of their get or produce. Stud Dogs or Brood Bitches must be entered in the Stud Dog or Brood Bitch Class and must be shown in the ring with their get or produce. The owner of the Stud Dog or Brood Bitch does not need to be the owner of the get or produce. The award is based on the merits of the get or produce. The Stud Dog/Brood Bitch must be examined to determine if it has a condition that would require its disqualification or excusal under the Dog Show Rules, AKC Policy, or the standard for its breed. Get/Produce must be entered in a regular class, Best of Breed (variety) competition, or some other non-regular class.

Stud Dog Class: For dogs that have sired two dogs or bitches entered in this show.

Brood Bitch Class: For bitches that have whelped two dogs or bitches entered in this show.

BEST IN PUPPY CLASSES

Best Puppy will be selected from the Puppy Class winners following the judging of Best of Breed. Only dogs not defeated in a Puppy Class are eligible to compete.
